




Enrollment Guide

The Enrollment wizard will consist of four steps that will allow you to verify your account information, set your username and password, and select your multi-factor authentication method.




On the first step, select the relationship of "Account Holder/Account Owner"



On the second step of the enrollment process you will enter:

- Equity Trust Company Account Number
- Last 6 of your Social Security Number
- Date of Birth

Tips for Selecting a Secure Password! Longer is Better: Consider using a "pass phrase" instead of a short password. A password consisting of a sentence, song lyric, quote, or even a few random words makes for a password that is easy for you to remember and hard for attackers to hack. We recommend that your password be at least 14 characters in length. Keep it Impersonal: Try to avoid using words, names, or phrases that might be easily associated with your interests such as names of family members, pets, favorite sports teams, or schools you have attended. Attackers comb social media looking for these clues! Don't Reuse Passwords: The password you use for your myEQUITY account should not be used for any of your other online accounts. When you reuse passwords, you put yourself at risk of having your myEQUITY account compromised due to a third-party website being breached. Username Password Retype Password Retype Password Next >

After this information has be entered and verified you will be instructed to create:

- Username
 - The username will be verified that it is available. If your username is not available, please enter an alternative.
- Password
 - Your password should be something that you will remember and is secure. The password must meet the following minimum requirements:
 - At least one upper and one lower case letter
 - A minimum of 14 characters
 - One digit is required or one special character (~,`,!,@,#,\$,%,^,&,*, (,),_,-,+,=,{,},[,], |,:,;,<,>,,,,?,/)
 - No spaces permitted or apostrophe and double quote





Once you have established your Username, and Password, you will be taken to the security step to select a secondary factor.



Multi-Factor Authentication

• Okta Verify Passcode

Okta Verify App is an app downloaded to your phone. The app provides the option to use a One Time Passcode (OTP) that is generated as a six-digit code that will be entered into myEQUITY for verification.

· Okta Verify Push Notification

Okta Verify App also allows you to select to have a push notification sent to your phone or smart watch. By confirming the request within the notification on your device, it will allow you to complete the login to myEQUITY without entering the code directly into the website.

Google Authenticator

Google Authenticator is an app that is download to your phone. The app generates a six-digit code that will be entered into myEQUITY for verification.

The following options are also available, these should only be selected if your device does not meet the requirements for either of the app above.

Text/SMS

You will receive a text to your primary phone listed on your Equity Trust account, with a code. That code that will be entered into myEQUITY for verification.

Voice

You will receive a robotic call to your primary phone listed on your Equity Trust account, with a code. That code that will be entered into myEQUITY for verification.

The list of options to select from include: two apps that are downloaded to your smart phone (Okta Verify or Google Authenticator) or a having a one-time passcode sent via Text/SMS or Voice.
